APPLICATION FOR REGISTRATION OF REAL ESTATE AGENT PART 1 DIVISION 2 1 July 2010 – 30 June 2011

Part 1 covering the Registration of Real Estate Agents is divided into two Divisions:-

- **Division 2** contains the names of real estate agents who are not carrying on a real estate business, that is, those agents employed by a real estate agent to manage an authorised place of business or employed in a sales or property management capacity.

Please note

- A real estate agent can be an individual, or a company, **but only an individual can be employed by another real estate agent.**
- A person, other than a qualified real estate agent, cannot imply that he/she is a qualified agent by the inclusion of his/her name in the company or business name of the real estate agency business.
- Please ensure that all questions are answered. If a question is not applicable mark "N/A" to indicate that the question has not been overlooked.
- Applications will be delayed if the form is not properly completed, the correct fee is not tendered, or the required additional documents are not supplied.

The following must be provided with this application:-

- Correct fees
- Copy of licence/registration/certificate or diploma
- Evidence of experience as property consultant in excess of 2 years (Certificate of employment, employee register extract).
