

Automatic Mutual Recognition (AMR) Notice of Intention

Notification

To be eligible to work in Tasmania under AMR you must hold a current licence or registration in your Home State or Territory for the activity covered by the occupation you intend to undertake in Tasmania. Property Agents who want to work in Tasmania under AMR from another State or Territory are required to notify the Property Agents Board of Tasmania of their intention to undertake regulated functions and show that the public protection requirements are met before commencing any activity in Tasmania.
